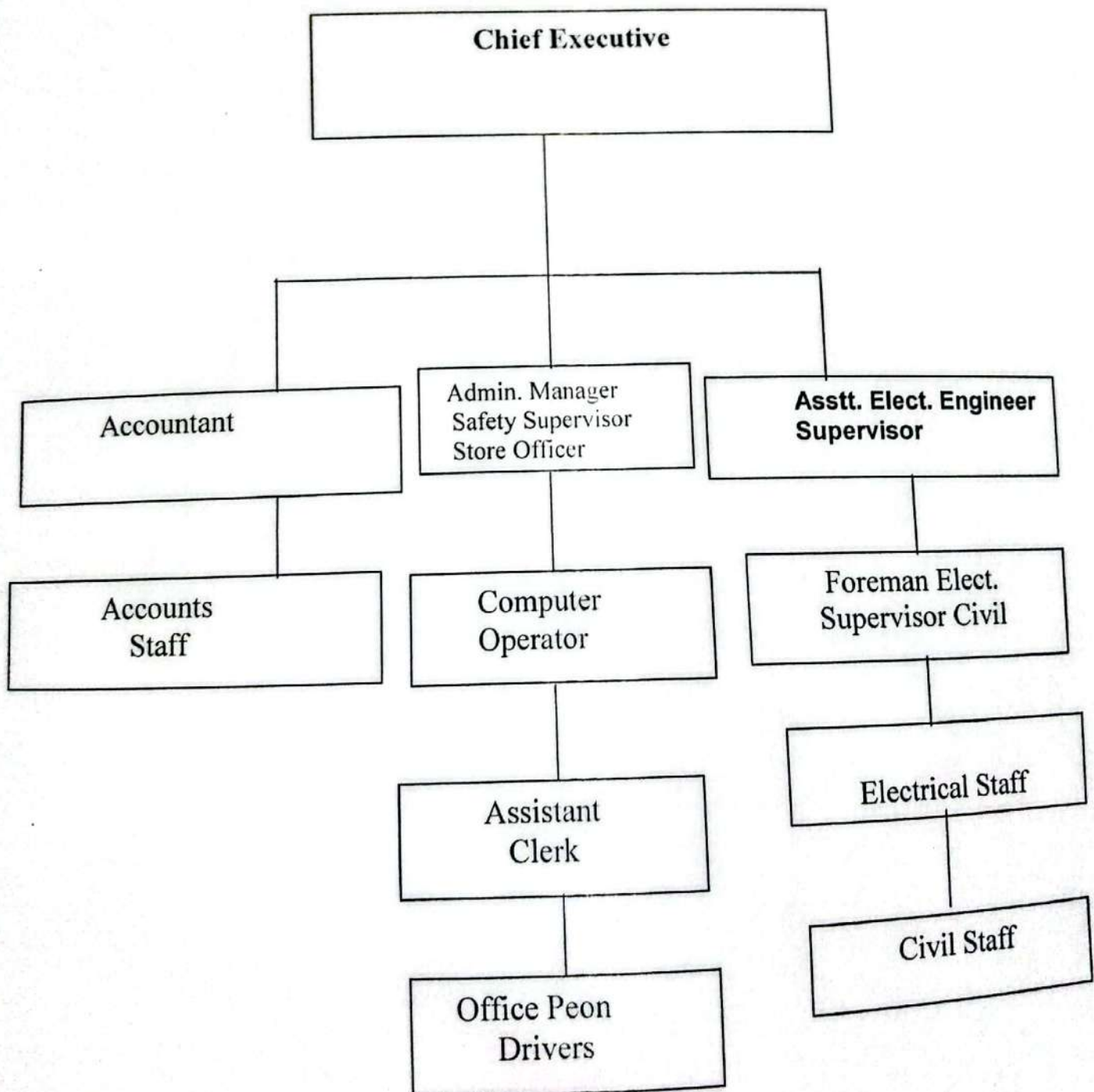

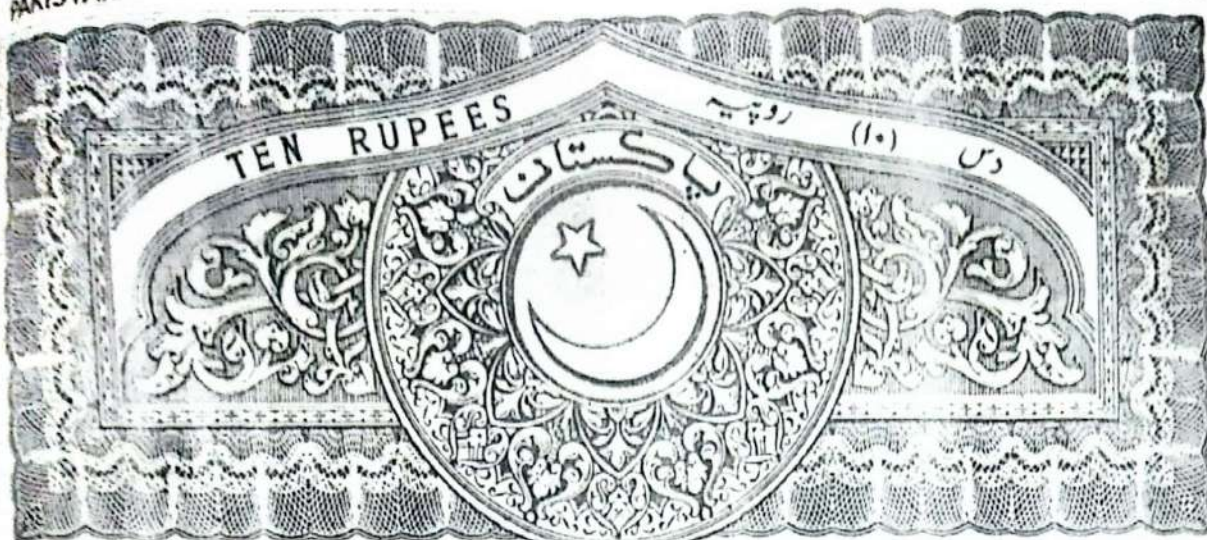

After friendly negotiation for value well dewatering work of CNCEC NO.11 Pakistan power complex project, both sides have achieved the agreement as following:

一、 甲方权利及义务

Party B should provide accommodation (meal and lodging) for his manpower;

4、 乙方自行协调地方关系, 甲方提供力所能及的帮助;

Party B should coordinate the local government and villager relations by themselves, Party A will try their best to provide necessary help.

三、 施工内容及材料要求

Work contents and material requests

1、 降水区域为 431 降水区域 (钻井 4 口), 钻井深度为 60 英尺, 滤管管径为 6 英寸, 数量共为 4 套, 具体位置由甲方在现场指定, 施工内容包括钻井、安置滤管、安装吸水管、水泵安装以及配套的水管等工作, 排水工程的运行及维护, 排水至集水坑, 甲方负责山水池排水至运河;

The dewatering area is 431 area. The depth of drilling is 60 ft, the diameter of pipe filter is 6 inch, and total amount is 4 pcs. Party A will mark the deep pond location, construction content including drilling, filter pipe setting, suction pipe fixing, diesel engine & water pump installation and correspondingly complete set of water pipe, etc, the operation and maintenance of drainage work. Party B will responsibility for drainage to collection pit, Party A is responsibility for drainage from the pit to Canal.

2、 乙方应安排两个操作工和两个帮工昼夜检查维护;

Party B should arrange 2 operators and 2 helps check and maintenance for mechanical condition day & night shift.

3、 甲方负责提供柴油机和水泵, 柴油机和水泵的维修配件, 以及提供柴油;

Party A is responsible for provide diesel engine and pump and hardware

of diesel engine & pump, and Party A should provide the diesel for the work.

- 4、 乙方负责协调施工中与当地地主以及当地政府的关系,不能影响降水工程的施工,保证地下水位顺利的降到甲方指定标高;

Party B is responsible for coordinating the relationship with local land owner and government during construction, which should not affect dewatering construction, ensuring the underground water table fall to the elevation level appointed by Party A smoothly;

- 5、 施工中所有人工、机械及材料(除柴油机和水泵外)均由乙方承担;

All the manpower, machine and material (excluding diesel engine & pump) for construction will be borne by Party B;

四、 合同价款及付款方式

Payment condition

- 1、 以上所有施工内容按固定总价 41 万卢比;

The lump sum price of all the above construction rate is RS.410,000.

- 2、 报价中包括所有直接和间接费用和税金,降水后所有设备材料属于甲方。

The contract price should include all the direct and indirect costs and taxes, all the pumps and pipe etc belong to Party A after the work.

- 3、 甲方应在钻孔完成后支付 150000 卢比的进度款,所有设备管道安装完成并开始出水后支付 150000 卢比的进度款,剩余 110000 的工程款在基础完成,所有设备管道拆除后支付。

Party A should pay RS.150,000 after completion of drilling;

Party A should pay RS.150,000 after completion of installation & running;

Party A should pay RS.110,000 after completion of concrete foundation & dismantle of the equipment.

五、 其它

Others

- 1、 钻孔完成时间为 11 月 5 日,设备安装完成并出水时间为 11 月 8 日,然后按照甲方要求的时间持续降水,保证地下水位不能影响

甲方基础的施工，延期一天对乙方罚款 1% 的合同价款，罚款总额不得高于合同总价的 10%。

The date of drilling completion is November 5, 2009, the date of installation completion is November 8, 2009; Party B should keep on the dewatering work as per the time requested by Party A, which must ensure the underground water table should not affect Party A's foundation construction. Party B will receive penalty(1% of contractual price) if it is one day deferred, the total amount of penalty should not be more than 10% of total contractual price.
